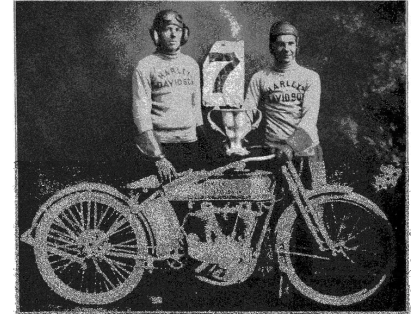

"LULL BEFORE THE STORM?—2019 WILL BE IN A TRANSITION YEAR"
